2022 MIPA State Highlights: Michigan

1. Please describe the primary private/public coalition in your state.

The <u>U-M Injury Prevention Center</u> is a funded <u>Center for Disease Control Injury Control Research</u> <u>Center</u> which conducts, translates, and accelerates injury prevention research into practice and policy to reduce the burden of injuries across the Great Lakes and US. Michigan Safe Kids Coalition is a statewide coalition made up of local organizations who create an environment where children 19 and under are free from accidental injury. This is accomplished through community partnerships, advocacy of best practices, public awareness and safety equipment and training on the proper use of safety devices. Current Initiatives or Conferences

Michigan Safer Opioid Prescribing Toolkit

To address a deficit in educational resources/tools for clinical providers and their patients, the UM-IPC, partnered with the Michigan Department of Health and Human Services (MDHHS) to create the Michigan Safer Opioid Prescribing Toolkit – a comprehensive, evidence-based, on-line resource. The toolkit is continually updated with the newest, most up to date information. New additions include the Post-Overdose Care in the ED toolkit, a section with resources for teachers & coaches, and most recently, a section with resources for nurses. As new resources and updates are rolled out, our team

works to find new ways to promote the toolkit and disseminate it to new audiences. To date, the toolkit has had over 30,000 unique pageviews.

Learning Without Violence: A School Violence Prevention Summit

The University of Michigan Injury Prevention Center in partnership with the National Center for School Safety and the University of Michigan Institute for Firearm Injury Prevention has organized a unique event for researchers, post-doctoral fellows, and students to disseminate research, facilitate new collaborations, and explore school violence prevention strategies.

<u>Checkpoints™ Parent Resource for Helping Teens Stay Safe as They Begin Independent</u> Driving

CheckpointsTM is an evidence-based resource that helps teens stay safe as they begin independent driving, educating parents about prevention strategies to address the greatest risks and about state teen driver laws. The free resource includes an interactive, personalized parent-teen driving agreement that helps set safety expectations for each checkpoint as the teen driver gradually increases driving complexity and responsibility.

Michigan Overdose Data to Action Dashboard

The Michigan Department of Health and Human Services has an interactive dashboard to highlight current fatal and nonfatal drug overdose trends. In addition, the site has data on health inequities, prevention strategies and federal, state, and local data reports.

Michigan Harm Reduction Summit

The Michigan Overdose Data to Action Program has helped support the Michigan Harm Reduction Summit since its inception. The Summit draws national and state presenters and participants to discuss harm reduction 101, stigma, cultural competency, housing, drug analysis, syringe service programs and more. Lived experience is centered in the planning and presentations. The 2023 Michigan Harm Reduction Summit is scheduled for May 17-18 in Lansing.
